Notes on completing the Form of Proxy

- 01 A member entitled to attend and vote at the Meeting may appoint a proxy of his or her choice. If the Chairman is to exercise the proxy vote, the space should be left blank. If any other proxy is preferred, enter the name of the proxy in the space provided. A proxy need not be a member of the Company but must attend the Meeting in order to represent you.
- 02 In the case of a corporation, the Form of Proxy must be either under seal or signed by a duly authorised officer or attorney.
- 03 In the case of joint holders, the Form of Proxy must be signed by the first named holder of the shares.
- 04 Only members or their proxies may attend the Meeting. Only members personally present may vote on a show of hands.
- 05 Completion and return of the Form of Proxy will not prevent a member from attending and voting in person at the Meeting if the member so wishes.
- 06 Please indicate with an X in the boxes in the Form of Proxy how you wish your proxy to vote on each of the resolutions. If no indication is given your proxy will have discretion to vote or abstain on those and all other resolutions or amendments thereto which may be voted on at the Meeting.
- 07 To be effective, the Form of Proxy, duly completed, must be lodged with the Company's Registrars, Lloyds TSB Registrars, The Causeway, Worthing, West Sussex BN19 6ZL, no later than 9:00 a.m. on Monday 6th February, 2006.
- 08 A member may register a proxy appointment electronically via the Lloyds TSB Registrars website, www.sharevote.co.uk, subject to the terms and conditions shown on the website. The deadline for submission of a proxy appointment in this way is the same as in Note 7 above. An electronic proxy appointment will be invalid unless it is lodged at the electronic address specified in this Note 8. Please note that any electronic communication found to contain a computer virus will not be accepted.
- 09 CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service should first read Note 4 on page 9 of the Notice of Annual General Meeting.
